Art-o-rama is the main international contemporary art fair in the South of France. An unmissable event that kicks-off the French contemporary art season at the end of summer, Art-o-rama features a unique and demanding selection of emerging local and international artists, bringing together over 50 galleries and publishers in Marseille, and online with the Salon Immatériel (a platform dedicated to works adapted to a virtual space). As a complement to the show, Art-o-rama offers bespoke VIP tours each year, showcasing the richness and the diversity of its cultural partners' summer exhibitions of contemporary art in Marseille and the surrounding region. Immersing yourself in the artistic highlights of the wider South, from Monaco's Nouveau Musée National to the MO.CO., the Fondation LUMA, Arles, Château La Coste, Villa Noailles, Commanderie de Peyrassol and Villa Carmignac among others.

VAT :

- Galleries located outside of France but within the European Union are not required to pay VAT if they clearly state their intra-community VAT number on the form (page 1) - Article 283-2 of the French General Tax Code (CGI)
- Galleries located outside the European Union are not required to pay VAT - Article 259-1 of the French General Tax Code (CGI)

Exhibition fee and booth:

The participation fee for Art-o-rama is €3,500 tax-excluded (20% tax) for galleries less than 7 years old and €4,000 tax-excluded (20% tax) for those more than 7 years old.

The exhibition space is designed by the exhibitor in line with their curatorial project, within the limit of 12 linear meters of one-side wall and 30 sqm of floor space. See examples on page 5. Please fill in the form on page 6.

The organizers may modify, in consultation with the exhibitor, the booth plan for the sake of the general fair's layout.

The participation fees include

- a maximum of 12 linear meters of one-side white plasterboard wall with a 3m height
- lighting
- power supply
- Wi-Fi connection

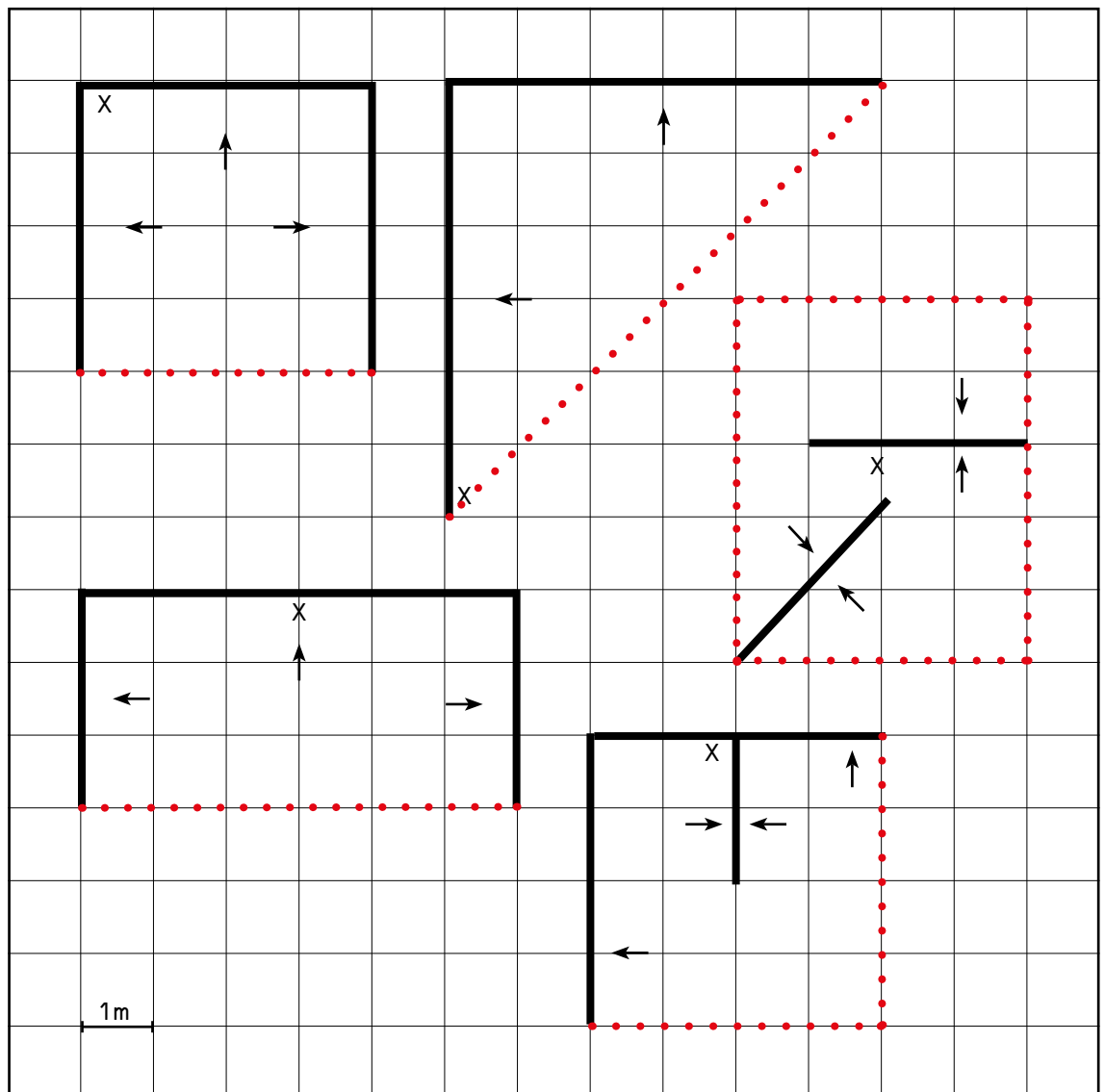

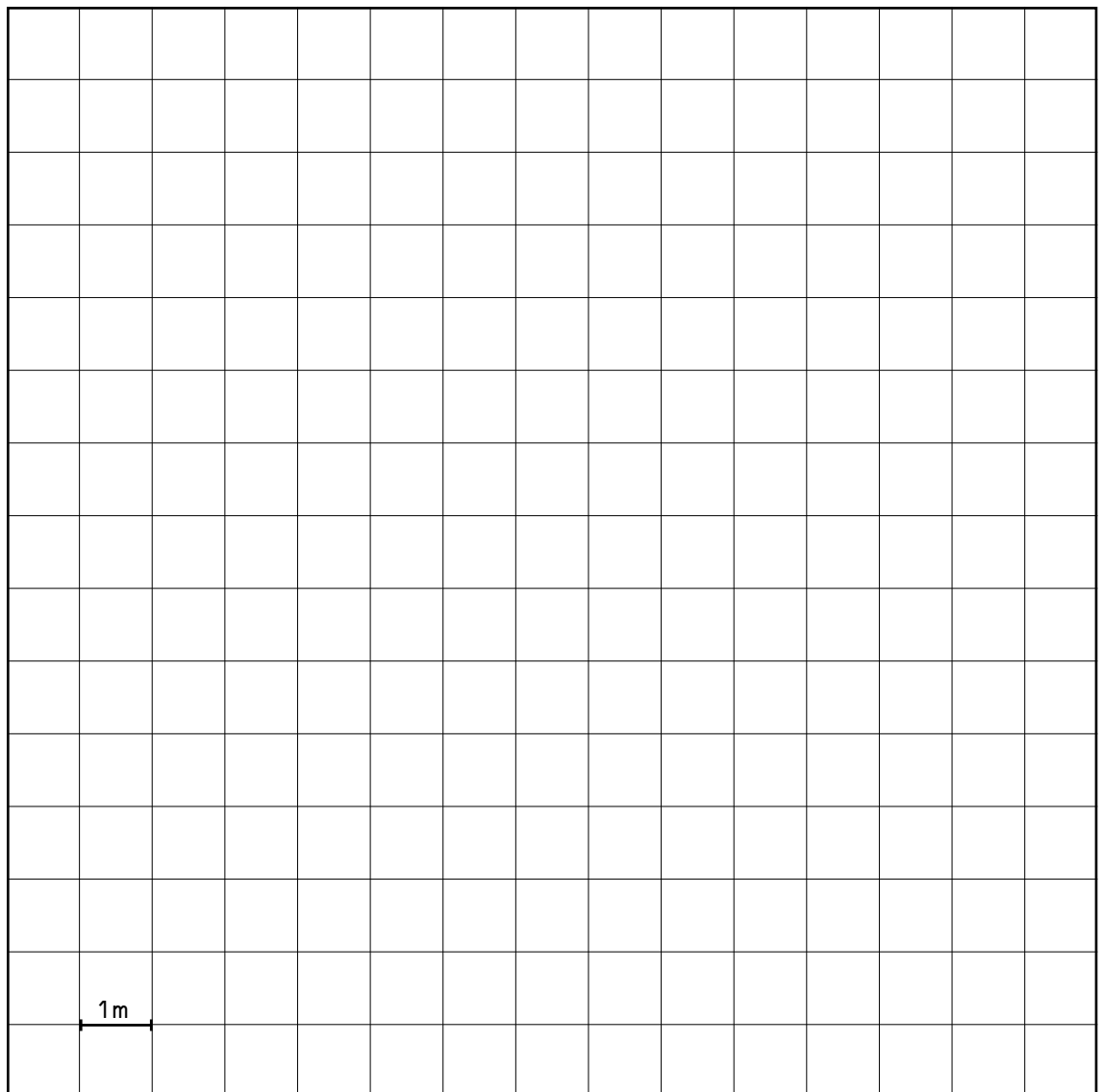


YOUR EXHIBITION SPACE:

PARTICIPATION TERMS AND CONDITIONS

Art-o-rama is produced by FRÆME PRODUCTION SASU for FRÆME, a non-profit organization based at La Friche la Belle de Mai, 41 rue Jobin, FR-13003, Marseille.

Art.1 - General Rules

The exhibitors who have been selected to participate in Art-o-rama accept, without any reservation, the terms and conditions in the present agreement and shall comply with any other rules and regulations of participation that may be issued by the organizer to supplement these terms and conditions in the interest of the event.

Art.2 - Participation

The selection of the application by the organizer entails the final compliance of the exhibitor to all the rules of the present agreement.

Art.3 - Fees

The exhibitor agrees to pay his / her application fee before sending his / her application. The exhibitor also agrees to pay its participation fee upon acceptance of the project at once, upon receipt of the invoice. No exhibitor will be able to settle on its stand before having paid the expenses.

Art.4 - Failure to participate

In case of a participation cancellation, the exhibition fees shall not be refunded except in cases of Force Majeure. The exhibitor shall also reimburse any expenses caused by their application.

Art.5 - Allocation of space

The booth configurations will be determined with the exhibitor on the basis of the technical information provided to the organizer.

The organizer commits to provide a booth to each exhibitor ; precise dimensions shall be set up with the exhibitor according to each project. The organizer commits to fit out each booth with minimum equipment (lights, electrical plugs, wifi). Any additional equipment shall be chargeable to the exhibitor. The final decision regarding the event site set-up shall be the organizers'. No claim will be accepted.

Art.6 - Transport, set-up and dismantling

Transport expenses to and from the event are entirely borne by the exhibitor. The installation and dismantling are made by the exhibitor.

Art.7 - Sales

Sales are allowed, nevertheless, any artwork withdrawn from the booth shall be replaced by another piece with equal

quality.

Art.8 Image Rights

The exhibitor authorizes the organizer to use photographs of their stand and the works exhibited there for communication purposes, both digital and printed, and in publications produced by the organizer.

Art.9 - Security

The organizer shall use reasonable endeavour to ensure a guard service outside the opening hours of the event. The exhibitors are responsible for the security of their equipment during public hours, set-up, and dismantling.

Art.10 - Insurance

In addition to the compulsory and appropriate liability insurance, the exhibitor shall obtain insurance from their insurance company to hedge other risks such as theft and damage against the artworks and exhibition equipments that may occur during the event, and also during the transport to and from the event. The exhibitor shall fully discharge the organizer from any responsibility in case of fire, breakage, leakage, water damage, or other disturbances, and any other damage not attributable to the organizer or their employees and servants.

Art.11 - Application of the Participation Terms and conditions

The organizer reserves the right to adjudicate at any time on all the disputed cases, or those not foreseen under these Participation Terms and Conditions. The organizer reserves the right to waive, add or alter any of those terms and conditions in the interest of the event.

Art.12 - Dispute

The parties will facilitate the amicable resolution of the dispute that may occur according to the interpretation or execution of the present agreement. In case of persistent disagreement, the competent court will be that of the jurisdiction of FRÆME, the non-profit structure organizing Art-o-rama.
